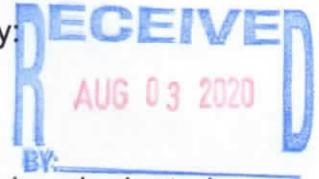


AN ORDINANCE relating to the annual budget and amendment thereof:
